## 2024 By the Numbers

CWPPs completed

TEA completed 3 CWPPs in the state of Colorado: Coal Creek Canyon Fire Protection District, Nederland Fire Protection District, and Jefferson County in Colorado.

NJ, NC, GA, TX, and LA.


Prescribed fire acres burned

## 2024 Department Accomplishments

## **Resilient Communities and Ecosystems**


- Worked with three Colorado communities to complete their Community Wildfire Protection Plans (CWPPs): Coal Creek Canyon, Nederland, and Jefferson County.
- Held three CWPP training courses in WA, OR, and British Columbia—our first international training. These reached over 90 participants.
- Hosted three national webinars on CWPP basics in collaboration with the Community Navigators Initiative, reaching hundreds of participants.
- Began research funded in part by the Bipartisan Infrastructure Law, focused on roadway safety for civilians and firefighters, and creating guidelines to enhance mitigation and preparedness for the Colorado Front Range.

## <u>Fire Management</u>

- Burned over 12,000 acres through prescribed fire.
- Built and burned 203 piles.
- Trained 327 students in fire and wilderness emergency medicine.
- Supported two fire crews:
  - Year-round Uwharrie crew in North Carolina
  - Seasonal Northern Colorado crew
- Trained 16 landowners in pile burning.
- Hosted the NOCO TREX Grasslands Workshop for 39 practitioners from 24 agencies.
- Assisted in implementation of the first ever Southern Michigan TREX with nearly 20 participants from over 10 agencies.
- Produced two burn plans for the City of Greeley.
- Led a fire research campaign at Fort Stewart with 92 researchers.
- Held five workshops on fire modeling and LiDAR tools for 113 participants.
- Started planning a 2025 research campaign in collaboration with NASA.
- Presented at the North Florida Prescribed Fire Council, reaching 107 in-person and 94 virtual attendees.
- Trained 44 AmeriCorps members in fire and chainsaw courses as part of the Gulf Corps Training program.
